**ORDER MODIFYING PRELIMINARILY APPROVAL OF CLASS ACTION
SETTLEMENT ORDER OF SEPTEMBER 10, 2009**

This matter came before the Court on October 21st, 2009 on the Parties Motion to

Modify Stipulation of Class Action Settlement and Order Preliminarily Approving Class Action

Settlement, due and adequate notice having been given and the Court being advised in the premises, IT IS HEREBY ORDERED, ADJUGED AND DECREED as follows:

1. The Parties' Motion is granted.
2. The Court's Order of September 10, 2009 and the Stipulation of Class Action

Settlement are hereby modified as follows:

- a. Paragraph 6 of the Order and the definition of "Class Representatives" as set forth on page 6 of the Agreement, shall be modified so as to refer to the Amended Addendum B that includes Holly Jacobs and revised proposed incentive award amounts. (See Amended Addendum B, a true and accurate copy of which is attached as Exhibit A).
 - b. Paragraph 5 of the Order, the definition of "Plaintiff's Steering Committee," and the listing of counsel comprising the same in Exhibit 4 shall be revised to include attorneys Philip Bock and Richard Doherty of Bock & Hatch, LLC and Brian Wanca of Anderson & Wanca.
 - c. The Definition of "Related Actions" as set forth on page 9 of the Agreement shall be modified to include *Jacobs v. Dada Entertainment LLC*, No. 08 LA 413 (McHenry County, IL).
3. All other terms of the Court's September 10, 2009 Order stand.
